NOTIFICATION No. 1.

In exercise of the powers conferred by sub-section (1) of Section 3 of the Azad Jammu and Kashmir Entertainments Duty Act of 1953, the Azad Jammu and Kashmir Government is pleased to order that the entertainments duty on all payments for admission to any entertainment shall be levied and paid at the following rates with effect from the first day of April, 1951 :-

Where the payment excluding the amount of the duty :-

NOTIFICATION No. 2.

In exercise of the powers conferred by sub-section (2) of section 7 of the Azad Jammu and Kashmir Entertainments Duty act 1953, the Azad Jammu and Kashmir Government is pleased to exempt the following entertainments from the liability to entertainments duty under the said Act.

All entertainments held within the limits of a cantonment area, in buildings and places of entertainment which are organized by the Military authorities for the benefit of troops and their families, provided a special certificate of exemption has been previously obtained on each

occasion from the Collector. Such certificate of exemption shall specify the place in which the entertainment is: to be held, the name of the organizing authority, the number of performance for which the certificate shall be valid and the period for which the certificate shall be in force ; provided that no such certificate shall be valid for a period exceeding ten days consecutively.

NOTIFICATION No. 3.

In exercise of the powers conferred by Section 12 of the Azad Jammu and Kashmir Entertainments Duty Act, 1953, the Azad Jammu and Kashmir Government is pleased to empower the Collector to exercise and perform all the powers and duties conferred or imposed upon the Government by the said Act other than those specified here-under :-

Section 5 (1)	.. Power to issued stamps ;
Section 5 (2) – (a)	.. Power to fix a percentage of the gross sum received.
Section 7 (2)	.. Power to exempt.
Section 8 (1)	.. Power to make rules.
Section 9	.. Power to prescribe the rank of Officers.
Section 12	.. Power to delegate and prescribe conditions of delegation.
