The following Act of the Assembly received the assent of the President on the 21st July, 1975, and is hereby published for general information:-

(ACT I OF 1975)

AN ACT To amend the Azad Jammu and Kashmir State Council Ordinance, 1970

WHEREAS in pursuance of sub-section (i) of Section 22 of the Azad Jammu and Kashmir Interim Constitution Act, 1974 it is expedient to amend the Azad Jammu and Kashmir State Council Ordinance, 1970 (Ordinance VI of 1970) in the manner hereinafter appearing;

It is hereby enacted as follows:-

- 1. Short title and commencement:** (1) This Act may be called the Azad Jammu and Kashmir State Council (Amendment) Act 1975.
(2) It shall be come into force at once and shall be deemed to have effect on and from the 23rd day of June 1975.
- 2. Amendment of Section 2, Ordinance VI of 1970:** In the Azad Jammu and Kashmir State Council Ordinance, 1970 (Ordinance VI of 1970) hereinafter referred to as the said Ordinance, in section 2-
 - (a) In sub-section (1) for the word 'sixteen' the words 'twenty-eight' shall be substituted.
 - (b) In sub-section (2), for the word 'four' the word 'six' shall be substituted;
 - (c) In sub-section (3), for the word 'Four' the word 'six' shall be substituted;
 - (d) In sub-section (4)-
 - (i) For the word 'one' the word 'two' shall be substituted; and
 - (ii) For the words 'twenty-four' the word 'forty' shall be substituted.
- 3. GENERAL:** In the said Ordinance, for the words "State Council" wherever occurring, the words 'Legislative Assembly' shall be substituted.

(ACT II OF 1975)

AN ACT to amend the Azad Jammu and Kashmir Delimitation of Constituencies Ordinance 1970

WHEREAS in pursuance of sub-section (1) of Section 22 of the Azad Jammu and Kashmir Interim Constitution Act, 1974, it is expedient to amend the Azad Jammu and Kashmir Delimitation of Constituencies Ordinance, 1970 (Ordinance VII of 1970) in the manner hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and Commencement:** (1) This Act may be called the Azad Jammu and Kashmir Delimitation of Constituencies (Amendment) Act, 1975.
(2) It shall come into force at once and shall be deemed to have taken effect on the 24th day of June, 1975.
2. **Amendment of Section 2, Ordinance VII of 1970:** In the Azad Jammu and Kashmir Delimitation of Constituencies Ordinance 1970 (Ordinance VII of 1970) hereinafter referred to as the said ordinance, in section 2, in clause (b) for the figure '1961' the figure '1971' shall be substituted.
3. **Amendment of Schedule to Ordinance VII of 1970:-** In the said Ordinance, for Schedule I, the following shall be substituted, namely:- see section 7(1)A

4. **Amendment of Schedule II to Ordinance VII of 1970:** In the said Ordinance In Schedule II.-

- (i) In entry (a), in column 2 for the figure '4' the figure 'six' shall be substituted.
 - (ii) In entry (b), in column 2 for the figure '4' the figure 'six' shall be substituted.
- 5. General Amendment:** In the said Ordinance, for the words 'State Council' wherever occurring the words 'Legislative Assembly' shall be substituted.
