ACT

to amend the Azad Jammu and Kashmir De-limitation of Constituencies Ordinance, 1970

WHEREAS it is expedient to amend the Azad Jammu and Kashmir De-limitation of Constituencies Ordinance, 1970 (Ordinance VII of 1970) for the purposes hereinafter appearing;

It is hereby enacted as follows: -

1. **Short title and Commencement.**- (1) This Act may be called the Azad Jammu and Kashmir (De-limitation of Constituencies (Amendment) Act, 1986.
(2) It shall come into force at once and shall be deemed to have taken effect on and from the 24th day of December, 1985.
2. **Amendment of Section 2, Ordinance VII of 1970.**- In the Azad Jammu and Kashmir De-limitation of Constancies Ordinance 1970, in section 2, for clause (b) the following shall be substituted, namely:-
“(b) “population” means the population as given in the latest census report.
3. **Amendment of Section 7, Ordinance VII of 1970.**- In the Azad Jammu and Kashmir De-limitation of Constituencies Ordinance, 1970 (Ordinance VII of 1970), hereinafter referred to as the said Ordinance in Section 7.-
 - (1) In subsection (1), in clause (b)-
 - (i) between the words Province and divide the words, and Federal and Federally Administered Tribal Areas’ shall be inserted; and
 - (ii) between the words ‘Provinces’ and “into” the words or areas shall be inserted.
 - (2) In subsection (2) in clause (b), between the words ‘Provinces’ and shall words ‘or areas’ shall be inserted.

4. **Amendment of Schedule II, Ordinance VII of 1970.**- In the said Ordinance schedule II, after the words 'North-West Frontier Province' wherever occurring the words 'Federal Capital and Federally Administered Tribal Areas' shall added.
5. **Savings.**- Notwithstanding any judgment, decree or Order of any Court including High Court, every thing done, all actions taken, notifications issued, Orders or appointments made, proceedings initiated, jurisdiction or powers exercised under the provisions of the Azad Jammu and Kashmir De-limitation of constituencies (Amendment) Ordinance, 1977 (Ordinance XXXIII of 1977) or its succeeding Ordinances issued from time to time shall be deemed to have been validly done, taken, issued made, initiated or exercised under this Act.
6. **Repeal.**- The Azad Jammu and Kashmir De-limitation of Constituencies (Amendment) Ordinance, 1986 (Ordinance IV of 1986) is hereby repealed.
