**(ACT XL OF 1986)**

**AN  
ACT**

to give effect to the financial proposals of Azad Kashmir

WHEREAS it is expedient to make provisions to give effect to the financial proposal of Azad Jammu and Kashmir and to amend certain laws for the purposes hereinafter appearing:

It is hereby enacted as follows: -

1. **Short title, Extent and Commencement.** - (1) This Act may be called the Azad Jammu and Kashmir Finance Act, 1986.
  - (2) It shall extend to the whole of Azad Jammu and Kashmir
  - (3) It shall come into force from 1st day of July, 1986.
2. **Definitions:** - In this Act, unless there is anything repugnant to the subject or content:
  - (a) "Agricultural land" means land used for agricultural purposes or for purposes subservient to agriculture.
  - (b) "Fee means a charge for providing medical service.

**"3. Levy of fee on Medical Service** (1) The medical Service fee shall be charged from every patient, except Government servants and their families, at the following rates: -

(a)	Chit (Purchee) fee:	Rupee one

(c)	Laboratory test fee	Rupee two
(d)	X-Ray charges	Rupee five per X-Ray
(2)	For examination and prescription of each animal, other than poultry bird, fee.	Rupee one."

4. **Amendment of Schedule I, Act II of 1899.**- In the Stamp Act 1899 (Act. I 1899), in Schedule I, for article 23, the following shall be substituted, namely “23” CONVEYANCE, as defined by section 2 (10) not being a transferred charge or exempted under No. 62

(a) in the case of Agricultural land.	Rupees three for every rupees one hundred or part thereof of the value of land:
(b) in any other case	Five rupees for every rupees one hundred or part thereof of the value of property.

5. **Powers to make rules:-** The Government may make rules for carrying out the purposes of this Act.
