No. 287-291/88. The following Act passé by the Assembly on 30th May, 1988, received the assent of the President on 31st day of May, 1988, is hereby published for general information:-

ACT

further to amend the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of Members) Act, 1975.

WHEREAS it is expedient to amend the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of Members) Act, 1975 (Act XX of 1975) in the manner hereinafter appearing:

1. **Short title and Commencement.** - (1) This Act may be called the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of Members) (Amendment) Act, 1988.
(2) It shall come into force at once and shall be deemed to have taken effect on and from the 15th of June, 1985.
2. **Addition of Section 5-A, Act, XX of 1975.**- In the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of Members) Act, 1975 (Act XX of 1975) after Section 5, the following new Section 5-A shall be added:-

“5-A. Free Travel.- (1) A member shall be provided during a year with such vouchers of the value of fifteen thousand rupees as would enable him to travel within Azad Jammu and Kashmir and Pakistan at any time without payment of any fare by Air or Rail.

Provided that, where a person becomes a Member during course of a year, the value of vouchers with which he is providing during that year shall not exceed that value which bears the same proportion to fifteen thousand rupees as the unexpired portion the year bears to a year.

(2) A Member who does not wish to be provided with vouchers shall be paid an allowance which bears the proportion of the value of the vouchers he would have been entitled to be provided with under sub-section

(1) as the sum of fifteen thousand rupees.

(3) Any vouchers with which a Member is provided sub-section (1) may be utilized by the family of Member.

(4) The utilization by a Member of any voucher with which he is provided under sub-section (1) for the purposes any journey for which he is entitled to any travelling allowance under this Act shall not in any way affect right to receive such allowance.

Explanation I.- In sub-section (3), 'family' means the spouses children of a Member and one Servant.

Explanation II.- In the section, 'Member' means and including Member of the Legislative Assembly, the Speaker, the Deputy Speaker, a Minister and a Parliament Secretary."
