ACT

to amend the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of Members) Act, 1975.

WHEREAS it is expedient to amend the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of Members) Act, 1975 (Act XX of 1975) in the manner hereinafter appearing:-

It is hereby enacted as follows:-

1. **Short title and Commencement.**- (1) This Act may be called the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of Members) (Amendment) Act, 1989.
(2) It shall come into force at once.
2. **Amendment of Section 8, Act XX of 1975.**- In the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of the Members) Act, 1975 (Act XX of 1975), hereinafter referred to as the said Act, Section 8, shall be substituted as under and shall be deemed to have been so substituted from June, 1985:-
 - “8. **Medical facilities.** (1) A member residing in Azad Jammu and Kashmir shall be entitled for himself and his family free indoor as well as outdoor Medical facilities of the standard admissible to a Class I Officer of the Government.
(2) A member residing out-side Azad Jammu and Kashmir shall be entitled to receive for himself and his family:-
 - (a) a sum of rupees five hundred per month in lieu of ordinary medical facilities.
 - (b) in case of hospitalization in Government Hospital, the actual expenditure incurred

by him; or

- (c) in case of Facility under clause (b) is not available, the actual expenditure incurred in Private Hospital, duly verified by the concerned member;

Provided that a certificate of non-availability by the concerned Government Hospital shall be necessary.

- 3. **Amendment of Section 10-B, Act XX of 1975.**- In the said Act, in Section 10-B,-
 - (a) for the figures “(i), (ii) and (iii)” wherever occurring the figure (1),(2) and (3) shall respectively be substituted; and
 - (b) in sub-section (3) as amended aforesaid for the word “clause” the word “sub-section” shall be substituted.
- 4. **Repeal.**- the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of Members) (Amendment) Ordinance 1988(Ordinance LXV of 1988) is hereby repealed.
