further to amend the Azad Jammu & Kashmir Legislative Assembly (Salaries, Allowances and Privileges of the Members) Act, 1975

WHEREAS, it is expedient to amend the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of the Members) Act, 1975 (Act XX of 1975) for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and Commencement.**- (1) The Act may be called the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of the Members) (Amendment) Act, 2007.
(2) It shall come into force at once and shall be deemed to have taken effect from 01.07.2006.
2. **Amendment of Section 3, Act XX of 1975.**- In the Azad Jammu and Kashmir legislative Assembly (Salaries, Allowances and Privileges of the Members) Act, 1975 (Act XX of 1975), hereinafter referred to as the Said Act, in Section 3, after sub-section (3), the following new sub-section (4) shall be added as under:-
“(4) The salary mentioned in sub-section (1) shall stand increased automatically at par with and equal to the increase in the salary of the civil servants as and when such increase is made by the Government.”
3. **Amendment of Section 4, Act XX of 1975.**- In the Said Act, in Section 4, for the words “**five hundred and fifty**”, the words “**six hundred and fifty**” shall be substituted.
4. **Amendment of Section 5, Act XX of 1975.**- In the Said Act, in Section 5, in sub-section (1), the words “**three rupees**” occurring in first proviso of clause (c) shall be substituted by the words “**five rupees.**”

5. **Addition of Section 7-C, Act XX of 1975.**- In the Said Act, after Section 7-B a new Section 7-C shall be added as under namely:-
“7-C **House Rent.**- A Member shall be entitled to receive house rent at the rate of ten thousand rupees per month.”
6. **Amendment of Section 10-A, Act XX of 1975.**- In the Said Act, in Section 10-A, for the words “**five thousand**”, the words “**ten thousand**” shall be substituted.
7. **Amendment of Section 10-C, Act XX of 1975.**- In the Said Act, in Section 10-C, for the words “**three thousand**”, the words “**five thousand**” shall be substituted.
8. **Amendment of Section 11-A, Act XX of 1975.**- In the Said Act, in Section 11-A, in the 2nd proviso the words “**eight thousand**” shall be substituted by the words “**fifteen thousand.**”
9. **Repeal.**- The Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances & Privileges of Member) (Amendment) Ordinance, 2007 (Ordinance XII of 2007) is hereby repealed.
