No. 56-61/LD/94. The following Act of the Assembly received the assent of the President on 19<sup>th</sup> January, 1994 is hereby published for general information:-

**(ACT II OF 1994)**

**AN  
ACT**

to amend the Azad Jammu and Kashmir President's Salary, Allowances and Privileges Act, 1975 (Act XIX of 1975) in the manner hereinafter appearing;

WHEREAS it is expedient to amend the Azad Jammu and Kashmir President's Salary, Allowances and Privileges Act 1975 (Act XIX of 1975) for the purposes hereinafter appearing.

It is hereby enacted as follows:-

1. **Short title and commencement:-** (1) This Act may be called the Azad Jammu and Kashmir President's (Salary, Allowances and Privileges (Amendment) Act, 1993.  
(2) It shall come into force at once.
2. **Amendment of Section 9, Act XIX of 1975:-** In the Azad Jammu and Kashmir President's Salary, Allowances and Privileges Act, 1975 (Act XIX of 1975) hereinafter referred to as the said Act, in Section 9 for the figures "40,000/-" the words "five lacs" shall be substituted and shall be deemed to have so substituted on and from the 1st day of July 1991.
3. **Insertion of new Section 9-A in Act XIX of 1975:-** In the said Act, after Section 9, the following new Section 9-A, shall be inserted and shall be deemed to have so inserted on and from the 1<sup>st</sup> day of July, 1991, namely:-  
**"9-A. Contract Allowance:-** A sum of rupees five laces per annum shall be placed at the disposal of the President for the periodical renewals and additions considered necessary for furnishing of the President's House."
4. **Amendment of Section 13, Act XIX of 1975:-** In the said Act, in Section 13, for the words "two hundred" the words "four hundred" shall be substitute and shall be deemed to have been so substituted from 1<sup>st</sup> day March, 1992.
5. **Insertion of Section 16-A, Act XIX of 1975:-** In the Said Act, after Section 16, the following Section 16-A shall be inserted:-  
**"16-A. In the case of resignation or completion of the tenure, the President, and in case of death, his family shall be entitled to the following privileges for a period of fifteen days after the President ceases to hold office:**

- (i) Residential Accommodation.
- (ii) Use of one official Car.
- (iii) One personal Assistant.
- (iv) One attendant.
- (v) Use of telephone at Residence.
- (vi) Police Guard.”

6. **Repeal:-** The Azad Jammu and Kashmir President’s Salary, Allowances and Privileges (Amendment) Ordinance, 1993 (Ordinance XLIV of 1993) is hereby repealed.
