Ordinance**

further to amend the Prime Minister Inspection and Implementation Commission Act, 2002

Whereas it is expedient further to amend the Prime Minister Inspection and Implementation Commission Act, 2002 (Act VI of 2002);

And Whereas the Azad Jammu and Kashmir Legislative Assembly is not in session and the President Azad Jammu and Kashmir is satisfied that circumstances exist which render it necessary to take immediate action;

Now Therefore in exercise of the powers conferred under sub-Article (1) of Article 41 of the Azad Jammu and Kashmir Interim Constitution, 1974, the President is pleased to make and promulgate the following Ordinance, for the purposes hereinafter appearing:-

1. **Short title, extent and commencement.**- (1) This Ordinance may be called the Prime Minister Inspection and Implementation Commission (Amendment) Ordinance, 2023.
(2) It shall extend to the whole of Azad Jammu and Kashmir.

- (3) It shall come into force at once and shall be deemed to have taken effect from 06.03.2023.
2. **Amendment of Section 3 (Act VI of 2002).**- In the Prime Minister Inspection and Implementation Commission Act, 2002 (Act VI of 2002), hereinafter referred to as the said Act, in Section 3, in sub-section (2), for the word "Government" the words "Prime Minister" shall be substituted.
3. **Amendment of Section 4 (Act VI of 2002).**- In the said Act, in Section 4, following amendments shall be made:-
(i) in sub-section (1), for the word "Government", wherever occurring, the words "Prime Minister" shall be substituted.
(ii) after sub-section (1), following new sub-section (1-a) shall be added:-
 “(1-a) In case, Chairman is appointed from amongst the Members of Azad Jammu and Kashmir Legislative Assembly, he shall be entitled to the same perks and privileges as are admissible to a Minister to the Government:
 Provided that if the Chairman is appointed from persons other than Secretaries to the Government or Member of Azad Jammu and Kashmir Legislative Assembly, his perks and privileges shall be determined by the Prime Minister.”
4. **Amendment of Section 5 (Act VI of 2002).**- In the said Act, In Section 5, for the word "Government", wherever occurring, the words "Prime Minister" shall be substituted.
