No. 954/SL/75. The following Ordinance made by the President on 1.4.1975, is hereby published for general information:-

(ORDINANCE V OF 1975)

AN ORDINANCE to amend the Azad Jammu and Kashmir (Board of Intermediate and Secondary Education) Ordinance 1973.

WHEREAS it is expedient to amend the Azad Jammu and Kashmir (Board of Intermediate and Secondary Education) Ordinance of 1973, for the purposes hereinafter appearing;

AND WHEREAS the Legislative Assembly is not in session and the President is satisfied that circumstances exist which render immediate legislation necessary;

NOW, THEREFORE, in exercise of the powers conferred by Section 41 of the Azad Jammu and Kashmir Interim Constitution Act, 1974, and all powers enabling him in that behalf, the President is pleased to make and promulgate the following Ordinance :-

1. **Short title and commencement:-** (1) This Ordinance may be called the Azad Jammu and Kashmir (Board of Intermediate and Secondary Education) (Amendment) Ordinance, 1975.
(2) It shall come into force at once and shall be deemed to have taken effect on the 15th day of January, 1975.
2. **Amendment of sub-section (1) of section 3:-** In the Azad Jammu and Kashmir (Board of Intermediate and Secondary Education) Ordinance, 1973, hereinafter referred to as the said Ordinance, in sub-section (1), of Section 3, the words of 'Secondary Education' shall be deleted.
3. **Amendment of Section 4:-** In the said Ordinance in sub-section (1) of Section 4 clauses (vii) and(viii) shall be omitted and clause (ix) shall be renumbered as (vii).
4. **Insertion of section 9-A:-** In the said Ordinance after section 9, the following new section 9-A, shall be inserted, namely:-

“9-A **Ceasure of jurisdiction of the Lahore Board:-** From the date of commencement of this Ordinance, the Board of Intermediate and Secondary Education, Lahore, shall cease to exercise its power in respect of the institutions within Azad Jammu and Kashmir.

Provided that Government may, by notification in the Official Gazette, authorise the Board of Intermediate and secondary Education of Secondary School Certificate and Intermediate Examinations for the years, 1973.”

5. **Addition of proviso to sub-section (2) of section 14:-** In the said Ordinance, in sub-section (2), of Section 14, for the full stop at the end a colon shall be substituted and thereafter the following proviso shall be added, namely:-

“Provided that the Controlling Authority may, at any time, review the word of the Chairman and if on such review it is satisfied that in the interest of the Board, or for any other sufficient cause it is necessary so to do, it may after giving the Chairman an opportunity of showing cause against the proposed action, reduce the term of office of the Chairman to such period as it may determine.”
