AN

ORDINANCE

to amend the Azad Jammu and Kashmir Political Parties Ordinance, 1979

WHEREAS it is expedient to amend the Political Parties Ordinance, 1979, in the manner hereinafter appearing ;

AND WHEREAS the President is satisfied that circumstances exist which render it necessary to take immediate action ;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 41 of the Azad Jammu and Kashmir Interim Constitution Act, 1974, the President is pleased to make and promulgate the following ordinance:-

1. **Short title and commencement.**- (1) This Ordinance may be called the Azad Jammu and Kashmir Political Parties (Amendment) Ordinance, 1979.

(2) it shall come into force at once.
2. **Amendment of Section 3, Ordinance CXX of 1979.**- In the Azad Jammu and Kashmir Political Parties ordinance, 1979 (Ordinance CXX of 1979), hereinafter referred to as the said Ordinance in Section 3, in sub section (1) for the comma between the words 'Sovereignty, and 'integrity, the words 'and' shall be substituted and between the words 'integrity, and 'or' the words 'of Pakistan' shall be inserted.
3. **Amendment of Section 5, Ordinance CXX of 1979.**- In the said Ordinance in Section 5,- (i) in sub-section (3) for clause (c) the following shall be substituted,-

- '(c) has belief in the ideology of Pakistan or the ideology of the state's accession to Pakistan and the integrity and sovereignty of Pakistan;
 - (ii) in sub-section (4), in clause (c) for the comma between the words 'Sovereignty' and 'Integrity' the words 'and' shall be substituted and between the words 'integrity' and 'or' the words 'of Pakistan' shall be inserted.
4. **Amendment of Section 7, Ordinance CXX of 1979.**- In the said Ordinance in Section 7, in sub-section (1) for the comma between the words 'sovereignty' and 'integrity' the word 'and' shall be substituted and between the words, '-integrity' and 'or' the words 'of Pakistan' shall be inserted.
