(ORDINANCE X OF 1985)

AN

ORDINANCE

to amend the Azad Jammu and Kashmir Political Parties Ordinance, 1984.

WHEREAS it is expedient to amend the Azad Jammu and Kashmir Political Parties Ordinance, 1984 (Ordinance CCI of 1984) in the manner hereinafter appearing;

AND WHEREAS the President is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 41 of the Azad Jammu and Kashmir Interim Constitution Act, 1974, the President is pleased to make and promulgate the following Ordinance:-

1. **Short title and Commencement.**- (1) This Ordinance may be called the Azad Jammu and Kashmir Political Parties (Amendment) Ordinance, 1985.
(2) It shall come into force at once.
2. **Amendment of Section 2, Ordinance CCI of 1984.**-
In the Azad Jammu and Kashmir Political Parties Ordinance, 1984 (Ordinance CCI of 1984), hereinafter referred to as the said Ordinance, in Section 2, after clause (a) the following new clause (aa) shall be inserted:-
“(aa) ‘Commissioner’ means the Chief Election Commissioner appointed under Section 50 of the Azad Jammu and Kashmir Interim Constitution Act, 1974.”
3. **Amendment of Section 3, Ordinance CCI of 1984.**- In the said Ordinance, in section 3, between the words “ideology or” and “the sovereignty” the words “ideology of state’s” accession to Pakistan or” shall be inserted.
4. **Amendment of Section 4, Ordinance CCI of 1984.**- In the said Ordinance, the explanation in Section 4, shall be omitted.
5. **Amendment of Section 6, Ordinance CCI of 1984.**- In the said Ordinance, in section 6, in sub-section (2), for the words and comma “the Election Commissioner hereinafter referred to as Commissioner shall,” the words “the Commissioner shall” shall be substituted.

6. **Amendment of Section 8, Ordinance CCI of 1984.**- In the said Ordinance, in Section 8, in sub-section (1) between the words “Ideology or” and “the sovereignty” the words “Ideology of State’s accession to Pakistan or” shall be inserted.
7. **Amendment of Section 10, Ordinance CCI of 1985.**- In the said Ordinance, in section 10, in clause (a) sub-section (1) for the words “and has not before a declaration” the words “and has not after a declaration” shall be substituted.
8. **General Amendment Ordinance CCI of 1984.**- In the said Ordinance for the words “Chief Election Commissioner” whenever occurring the word “Commissioner” shall be substituted.
