No. 249-53/LD/88, The following Ordinance made by the President on the 18th day of May, 1988, is hereby published for general information:-

(ORDINANCE XXIX OF 1988)

AN

ORDINANCE

to amend the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of members) Act, 1975.

WHEREAS it is expedient to amend the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of Members) Act, 1975 (Act XX of 1975) in the manner hereinafter appearing;-

AND WHEREAS the legislative Assembly is not in session and the President is satisfied that the circumstance exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 41 of the Azad Jammu & Kashmir Interim Constitution Act, 1974, the President is pleased to make and promulgate the following Ordinance:-

1. **Short title and Commencement.**- (1) This Ordinance may be called the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of Members) (Amendment) Ordinance, 1988.

(2) It shall come into force at once.

2. **Amendment of Section 8, Act XX of 1975.**- In the Azad Jammu and Kashmir Legislative Assembly (Salaries, Allowances and Privileges of the Members) Act, 1975 (Act XX of 1975), hereinafter referred to as the said Act, Section 8, shall be substituted as follows:-

“8. **Medical facilities.** (1) A member residing in Azad Jammu and Kashmir shall be entitled for himself and his family free indoor as well as outdoor Medical facilities of the standard admission to a Class I Officer of Government.

(2) A member residing out-side Azad Jammu and Kashmir shall be entitled to receive for himself and his family:-

- (a) a sum of rupees four hundred per month in lieu of ordinary medical facilities;
- (b) in case of hospitalization in Government Hospital, the actual expenditure incurred by him.”

3. **Amendment of Section 10-B, Act XX of 1975.**- In the said Act, in Section 10-B,-
- (a) for the figures “(i), (ii) and (iii)” wherever occurring the figure (1) and (3) shall respectively be substituted; and
 - (b) in sub-section (3) as amended aforesaid for the word “clause” the word “sub-section” shall be substituted.
