AN

ORDINANCE

to amend the Azad Kashmir Logging and Sawmill Corporation Ordinance, 1968.

WHEREAS it is expedient to amend the Azad Kashmir Logging and Sawmill Corporation Ordinance, 1968 (Ordinance IV of 1968) for the purposes hereinafter appearing;

AND WHEREAS the legislative Assembly is not in session and the President is satisfied that the circumstance exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 41 of the Azad Jammu and Kashmir Interim Constitution Act, 1974 the President is pleased to make and promulgate the following Ordinance:-

1. **Short title and Commencement.**- (1) This Ordinance may be called the Azad Kashmir Logging and Sawmill Corporation (Amendment) Ordinance, 1988.
 - (2) It shall come into force at once.
2. **Amendment of Section 2, Ordinance of 1968.**- In the Azad Kashmir Logging and Sawmill Corporation Ordinance 1988 (Ordinance IV of 1968) hereinafter referred to as said Ordinance, Section 2:-
 - (a) clause (iii) shall be substituted, as under,-

“(iii) Additional Chief Secretary (Development) means the Additional Chief Secretary (Development) of Azad Government, of the State of Jammu and Kashmir.”
 - (b) after clause (vii) the new clause (vii-a) shall be added.-

“(vii-a) ‘Minister’ means forest Minister, Azad Government of the State of Jammu and Kashmir.”
3. **Amendment of Section 6, Ordinance, IV of 1968.**- In the said Ordinance, for Section 6, the following shall be submitted namely:-

“6 **Composition of Azad Kashmir Logging and Sawmill Corporation Board.**-(1)The Board shall consist of the

following Directors, namely.-

- (a) Forest Minister;
- (b) Additional Chief Secretary (Development);
- (c) Managing Director, who shall be appointed by the Govt.
- (d) Secretary Finance Department;
- (e) Chief Conservator of Forests; and
- (f) two members nominated by the Government, amongst whom one shall be an M.L.A.

(2) Forest Minister shall be the Chairman of the Board.

(3) Board of Directors AKLASC may nominate only officer of Azad Kashmir Logging and Sawmill Corporation, to act as Secretary to the Board of Directors.

(4) The Managing Director shall be the Executive Head, and each Director shall perform such duties as may be prescribed by regulations.

(5) The Secretary Finance shall be the Financial Director Azad Kashmir Logging and Sawmill Corporation who shall exercise such power and discharge such duties as may be prescribed.”
