(ORDINANCE II OF 1992)

AN

ORDINANCE

to give effect to the financial proposal of Azad Government of the State of Jammu and Kashmir.

WHEREAS it is expedient to make provisions to give effect to the financial proposals of Azad Government of the state of Jammu and Kashmir and to amend certain Laws for the purposes hereinafter appearing;

AND WHEREAS the Legislative Assembly is not in session and the President is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 41 of the Azad Jammu and Kashmir Interim Constitution Act, 1974, the President is pleased to make and promulgate the following Ordinance:-

1. **Short title and Commencement.**- (1) This Ordinance may be called the Azad Jammu and Kashmir Finance (Amendment) Ordinance, 1992.
(2) It shall come into force at once and shall be deemed to have taken effect on and from 14th September, 1991.
2. **Amendment of Section 3, Act XL of 1986.**- In the Azad Jammu and Kashmir Finance Act, 1986 (Act XL of 1986) in sub-section (1) of Section 3, for clauses (b) to (i) the following shall be substituted, namely.-

The poor will be exempted from the above fee and the fee on the account will be paid by the Institute concerned from the Zakat fund placed at their disposal."

3. **Amendment of Section 3, Act VIII of 1988.**- In the Azad Jammu and Kashmir Finance Act, 1988 (Act VIII of 1988) for Section 3, the following shall be substituted namely:-

"3. Levy of tuition fee and admission fee in Government Educational Institutions.- The tuition fee shall be charged at the following rates:-
