AN

ORDINANCE

to give effect to the financial proposal of Azad Government of the State of Jammu and Kashmir.

WHEREAS it is expedient to make provisions to give effect to the financial proposals of Azad Government of the State of Jammu and Kashmir and to amend certain Laws for the purposes hereinafter appearing;

AND WHEREAS the Legislative Assembly is not in session and the President is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 41 of the Azad Jammu and Kashmir Interim Constitution Act, 1974, the President is pleased to make and promulgate the following Ordinance:-

- 1. <u>Short title and Commencement.</u>- (1) This Ordinance may be called the Azad Jammu and Kashmir Finance (Amendment) Ordinance, 1992.
 - (2) It shall come into force at once.
- 2. **Amendment of Section 3, Act XL of 1986.-** In the Azad Jammu and Kashmir Finance Act, 1986 (Act XL of 1986) in Section 3,-
 - (a) in sub-section (1) clause (a) shall be omitted;
 - (b) for clauses (b) to (i) the following shall be substituted, namely:-
 - "(b) Admission fee for Indoor Patients Rs. One
 - (c) Laboratory Test Fee.
