(ORDINANCE III OF 1994)

AN ORDINANCE

to amend the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges) Act, 1975

WHEREAS it is expedient to amend the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges) Act, 1975 (Act XVIII of 1975) for the purposes hereinafter appearing;

AND WHEREAS the Legislative Assembly is not in session and the President is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 41 of the Azad Jammu and Kashmir Interim Constitution Act, 1974, the President is pleased to make and promulgate the following Ordinance:-

- 1. <u>Short title and commencement.</u> (1) This Ordinance may be called the Azad Jammu and Kashmir Ministers (Salaries, Allowances and Privileges) (Amendment) Ordinance, 1994.
 - (2) It shall come into force at once.
- Amendment of Section 6, Act XVIII of 1975.— In the Azad Jammu and Kashmir Ministers (Salaries, Allowances Privileges) Act, 1975 (Act XVIII of 1975), hereinafter refer to as the said Act, in Section 6, for the words "four thousand and "three thousand" the words "six thousand" and "five thousand" shall respectively be substituted and shall be deemed to have so substituted from the 1st day of January, 1992.
- 3. Amendment of Section 8, Act XVIII of 1975.— In the said Act, in sub-section (1) of Section 8, for the words "one lac" and "sixty thousand" the words "two lacs" and "one lac" shall respectively be substituted.
- **4.** Omission of Section 10, Act XVIII of 1975.— In the said Act, Section 10 shall be omitted.

- **5.** <u>Amendment of Section 11, Act XVIII of 1975.-</u> In the said Act, Section 11,-
 - (a) for the words "of one hundred and twenty five rupees per day" the words "at such rate as may be determined by the Government from time to time," shall be substituted; and
 - (b) after clause (iii) the following new, clause (iv) shall be inserted, namely:-
 - "(iv) while on tour, if accommodation is not available in the rest house and a Minister stays in a hotel, he shall be paid the actual room rent on production of proper receipt."
- **6.** <u>Amendment of Section 21, Act XVIII of 1975.-</u> In the said Act, in Section 21 the words "and an amount of seventy five thousand" and "respectively" shall be deleted.
