ORDINANCE

further to amend the Azad Kashmir Courts and Laws Code, 1949.

WHEREAS it is expedient to amend the Azad Kashmir Courts and Laws Code, 1949, for the purposes hereinafter appearing;

AND WHEREAS the Legislative Assembly is not in session and the President is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 41 of the Azad Jammu and Kashmir Interim Constitution Act, 1974, the President is pleased to make and promulgate the following Ordinance:-

- 1. <u>Short title and Commencement.</u>- (1) This Ordinance may be called the Azad Kashmir Courts and Laws Code, (Amendment) Ordinance, 1992.
 - (2) It shall come into force at once.
- 2. <u>Amendment of Section 5, Azad Kashmir Court and Laws Code 1949.</u> In the Azad Kashmir Courts and Laws Code, 1949, hereinafter referred to as the said Code, Section 5,-
 - (a) in sub-section (1) the words "as may be appointed from time to time by the Government on such Salary and allowances as may be fixed in this behalf by the Government" shall be omitted.
 - (b) sub-section (2) and (3) shall be deleted.
- 3. Omission of Section 6, 8 and 12 Azad Kashmir Courts and Laws Code 1949.— In the said Code, Section 6, 8 and 12 shall be omitted.

- 4. <u>Amendment of Section 17, Azad Kashmir Courts and Laws</u>
 <u>Code, 1949.</u> In the said Code, in Section 17, sub-section (2) shall be deleted.
- 5. <u>Amendment of Section 30, Azad Kashmir Courts and Laws</u> Code, 1949.-In the said Code, in Section 30,-
 - (a) in sub-section (1) the words "after consultation with the High Court" shall be deleted.
 - (b) sub-section (2) shall be deleted.
- 6. Omission of Section 35, Azad Kashmir Courts and Laws Code, 1949.- In the said Code, Section 35 shall be omitted.
- 7. Amendment of Section 44, Azad Kashmir Courts and Laws Code, 1949.- In the said Code, in Section 44, for the words "by the Government" the words "as provided by the relevant law" shall be substituted.
- 8. Omission of Sections 50, 51, Azad Kashmir Courts and Laws Code, 1949.- In the said Code, Section 50 and 51 shall be omitted.
- 9. <u>Amendment of Sections 52, Azad Kashmir Courts and Laws</u>
 <u>Code, 1949.</u> In the said Code, in Section 52, in sub-section (1), clause (e) shall be omitted.
- 10. Omission of Section 55, 56, and 59, Azad Kashmir Courts and Laws Code, 1949.- In the said Code, Section 55, 56 and 59 shall be omitted.
