No. 2287/LD/Leg(A)/85. The following Act of the Assembly received the assent of the President on 25<sup>th</sup> day of November, 1985, is hereby published for general information:-

## (ACT XXIX OF 1985)

#### AN

#### **ACT**

to provide relief to the distressed persons in Azad Jammu and Kashmir

WHEREAS it is expedient to provide relief to the distressed persons in Azad Jammu and Kashmir;

It is hereby enacted as follows:-

- 1. <u>Short title, extent and Commencement.</u>- (1) This Act may be called the Azad Jammu and Kashmir Distressed Persons Relief Act, 1985.
  - (2) It extends to the whole of Azad Jammu and Kashmir.
  - (3) It shall come into force at once and shall be deemed to have taken effect on and from 5<sup>th</sup> day of November, 1985.
- 2. <u>Definitions.</u>- In this Act, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them that is to say:-
  - (a) "Competent officer or Board of officers" means an officer or Board appointed by the Government to function as such under Section 4 of this Act;
  - (b) "Distressed person" means and includes any person who lives in Azad Jammu and Kashmir and who--
    - (i) has been physically or financially damaged on account of any accident, fire, epidemic, rains, or any other calamity and in the opinion of the competent officer or Board of officers deserves aid or relief in order to enable him to continue the normal pursuits of his life for the time being or till the effects of the damage subsidize; or

- is a legal heir of a person who has lost his life in an accident, fire, epidemic, rains or any other calamity and in the opinion of the competent officers or Board of Officers, it is expedient to provide him relief];
- (c) "Government" means the Azad Government of the state of Jammu and Kashmir.
- (d) "The Distressed Persons Relief Fund" means a fund created or established as such and operated under this Act;
- (e) "State Subject" means a State Subject as defined under the Dogra Regime Government Notification No. I-L/84, dated the 20<sup>th</sup> April, 1927.
- 3. The Distressed Persons Relief Fund.- The Government may establish a fund to be called "the Distressed Person Relief Fund" (hereinafter referred to as "the fund") in order to meet the requirements for relief of distressed persons under this Act or rules made thereunder.
- 4. <u>Competent officer or Board of Officers.</u> The Government may a competent officer or Board of officers to make recommendations to the Government about the distressed person(s) entitled to get relief out of the fund referred to in Section 3. In making recommendations to the Government under this Section, the competent officer or Board of officers shall be guided by the rules made under this Act and the assessment made by the Assessment Committee appointed by the Government for relief assessment purposes.
- 5. **Pending cess.** The cases pending before coming into force of this Act shall be finally disposed of under this Act.

- (a) the person or person who deserve relief under the said Act;

Provided that the maximum relief which can be granted to an individual in case of death or injury or damage to property shall not exceed the amount mentioned in the schedule attached to this Act.]

Provided that when an area is notified as natural calamity affected area, the Government may consider a special dispensation for the effectees including revision of rates of assistance.]

- 7. Orders.- On receipt of the recommendations of the competent officer or the Board of officers, Government may accept, rescind or modify as the recommendations or pass such other orders as it deem fit.

Provided that the maximum relief which can be granted to an individual or Collective cess shall not exceed ten percent of the total loss assessed;

Provided further that in individual cases the relief shall be given in very exceptional and hard cases."

"Power of President to Grant Relief.- (1) Notwithstanding anything contained in clause (b) of Section 2 and Section 6 of this Act or any other law for the time being in force, the President may order one time grant of a sum not exceeding Rupees twenty thousand only in case of a calamity to be placed at the disposal of District authorities for providing immediate relief in collective cases for provision of food, shelter, clothing, Medicine and other necessary relief from the Relief Fund. The District Officer shall subsequently, within a period of three months, render an account of this amount to Accountant General, Azad Jammu and Kashmir, for verification and audit.

calamity affected Areas.- Notwithstanding anything contained in clause (b) or Section 2 and Section 6 of the said Act or any other law for the time being enforce, the Government may grant adequate amount only in case of a mass calamity affected areas, to be placed at the disposal; of District Authorities for providing immediate relief in collective cases for provisions of food, shelter, clothing, medicine and other necessary relief from the Relief Fund. The District Officer shall subsequently within a period of three months, render on account of this amount to Accountant General, Azad Jammu and Kashmir, for verification and audit.]

- <sup>1</sup>[8-A. <u>Delegation of Powers.</u> The Government may delegate its powers under this Act to any person or authority.
- 9. <u>Power to make rules.</u>- (1) The Government may, by notification in the Official Gazette make rules for carrying out the purposes of this Act.
  - (2) In particular and without prejudice to the generality of the foregoing provision, such rules may provide—
  - (a) the amount of relief for different categories of the distressed persons;
  - (b) the manner in which preliminary enquiries should be made;
  - (c) the manners in which different accounts, entries or certificates are to be maintained, made or given in this behalf;
  - (d) such other matters as are necessary to facilitate the operation of this Act,
- 10. <u>Savings.</u>- Notwithstanding any judgment, decree or Order of any Court including High Court, everything done, all actions taken, notifications issued, Orders or appointments made, proceedings initiated, jurisdiction or powers exercised under the provisions of the Azad Jammu and Kashmir Distressed Person Relief Ordinance, 1980 (Ordinance CXXX of 1980) or its succeeding
