The following Acts of the Assembly received the assent of the President on the $01^{\rm st}$ July 1975 and are hereby published for general information:-

(ACT VI OF 1975)

AN ACTto provide for the Registration of Citizen of Azad Jammu and Kashmir State and issue of identity Cards to them.

WHEREAS it is expedient to provided for the registration of citizen and issue of identity cards to them, and for matters ancillary thereto;

It is hereby enacted as follows:-

- 1. Short title, extent, commencement and application:(1)This Act may be called the National Registration Act, 1975.
 - (2) It extends to the whole of Azad Jammu and Kashmir.
 - (3) It shall come into force at once.
 - (4) It shall apply to all citizens wherever they may be.
- **2. Definitions.-** In this Act, unless there is anything repugnant in the subject or context:-
 - (a) 'Citizen' means a person who is or is deemed to be, a 'State Subject' as defined in the Azad Jammu and Kashmir Interim Constitution Act 1974;
 - (b) 'Government' means the Azad Government of the

State of Jammu and Kashmir;

- (c) 'Prescribed' means prescribed by rules;
- (d) 'Registration Officer' means the 1*** [Director General, Director, Deputy Director and Assistant Director] Registrar General or 2 Inspector] appointed under section 3, and includes any officer to whom the powers of any officer have been deligated under this Act, and
- (e) 'Rules' means rules made under this Act.
- **3. Registration Officer:**(1) For the purposes of this Act, Government may appoint;
 - (a) A*** [Director General] for the whole of Azad Kashmir.
 - ³[(b) A***[Directorand as many Deputy Directorand Assistant Director], District Registrars, Registrars Inspectors] .as it may consider necessary. A District Registrar for each revenue district; and
 - (c) As many Registrars for the local areas as it may consider necessary.
 - (2) Director and every ***[Deputy Director, Assistant Director], District Registrar, Registrar and Inspector shall exercise his powers and perform his functions under this Act and rules.

- (a) Within such area as the***[Director General] subject to the general supervision and control of the Government, may direct; and
- (b) under the general supervision and control of, and in accordance such instructions as may be given in this behalf by, the***[Director General]

Every District Registrar and Registrar shall exercise his powers and perform his functions under this Act and rules under the general supervision and control of, and in accordance, with such instructions as may be given in this behalf by, the***[Director General]

- **4. Registration of citizen:**(1) Within such time as the Government may, by notification in the official Gazette specify in this behalf;
 - (a) every citizen in or out of Azad Kashmir who has attained the age of eighteen years shall get himself;
 - (b) a parent or guardian of every citizen who has not attained that age shall get such citizen registered in accordance with the provisions of this Act.
 - ¹[(2) An application for registration shall be made in such form and authority as may be prescribed." And]

And shall be made to such authority as may be prescribed.

IDENTITY CARDS

- 5. (1) The***[Director General] shall cause to be issued to every citizen who has attained the age eighteen years and got himself registered under section 4, a card ²[in the prescribed form] hereinafter referred to as the Identity Cards.
 - (2) Every person to whom an identity card is issued shall be responsible for its safe custody and for maintaining it in proper shape.
- Gazetted Officer under the control of, and authorized by, the ***[Director General] in this behalf may require a person to whom an identity card has been issued to produce the card for inspection before him or, if it is not in his possession when so required, to produce it within such time, before such officer and at such place as the Registration officer or the officer so authorized may direct.
- 7. **Surrender of identity card:**(1)In case of the death of any holder of an identity card, his identity card shall be surrendered or given up to the District Registrar by the spouse, heir or next of Kin, as the case may be, of such holder within sixty days of such death.
 - ³["(1-A) When a citizen who has not attained the age of eighteen years dies, a parent or the guardian of

- such citizen shall report the death Registrar within sixty days of such death."]
- (2) The holder of an identity card who ceases to be a citizen shall surrender or give up his identity card to the District Registrar within sixty days of his ceasing to be a citizen.
- 8. Identify cards necessary for certain purposes.- (1) No citizen who has attained the age of eighteen years but does not posses or produce an identity card shall be granted a passport, permit or other travel documents for going out of Pakistan.
 - (2) Any officer charged with the duty of conducting the poll at an election to the Azad Kashmir Assembly or to a Municipal Committee, or other local authority may, for the purpose of satisfying himself as to the identity of any person, require such person to produce his identity card.
 - (3) The Government may, by notification in the official gazette specify any other purposes for which the production of an identity card shall be necessary.
 - (4) The identity card issued to any person shall be proof of his identity for any purposes for which his identity is required to be established.
- 9. **Power to call for proof of information:**The***[Director General] or any person authorized by him in this behalf may require a person who has given any information in pursuance of this Act, to furnish such documentary or other evidence of the truth of that information as it is within the power of that person to furnish.
- **10. Information not be divulged.-**Any person who --
 - (a) Being a person employed for the purposes of this Act, publishes or communicates to any person, otherwise than in the ordinary course of such employment, any information acquired by him in

the course of the employment; or

(b) Having possession of any information which to his knowledge has been disclosed in contravention of this Act, published or communicates that information to any other person, shall be punishable with imprisonment for an term which may extend to six months, or with fine which may extend to one thousand or with both;

Provided that nothing in this section shall apply to any publication; or communicating or information made-

- (i) For the purpose of an judicial proceedings;
- (ii) To any Gazette Officer authorized by the Government or the***[Director General].

11. **Penalties.- 1.** Any person who-

- (a) does not, without reasonable cause, apply for Registrant as required by section 4;
- (b) for any of the purposes of this Act makes any statement or furnishes any information which he knows or has reason to believe to be false in any material particular or which he does not believe to be true'
- (c) conceals, or refuses to furnish, any information which he ought to disclose or furnish;
- (d) obliterates or changes any particulars written in the identity card;
- (e) forges any identity card or makes or has in his possession any document so closely resembling an identity card as to be a calculated to deceive;
- (f) fails, without reasonable cause, to report to any

- registration officer any loss of the identity card within thirty days of such loss;
- (g) allows any other person to have possession of an identity card of the custody of which he is responsible;
- (h) refuses or fails to produce or surrender an identity card as required under Section 6 of this Act.
- (i) does not, without reasonable cause, apply for a identity card within ninety days of his attaining the age of eighteen years; or
- (j) knowledge contravenes any other provision of this Act or the rules, shall in addition to any other penalty to which he may be liable under any other law, be punishable [with rigorous imprisonment for a period not exceeding three months, or with fine not exceeding one thousand rupees, or with both.]

²["(2) Any person who attests verifies any statement or information made or furnished for the purpose of this Act which he knows or has reason to believe to be false in any material particular or which he does not believe to be true shall be punishable with fine not exceeding one thousand rupees, or with simple imprisonment for a period not exceeding three months or with both."]

12. Cognizance of offence.- No court shall take cognizance of any offence under this Act except upon complaint tin writing made by the***[Director

General] or any Gazetted officer authorized by him in this behalf.

- 13. Offence triable summarily: Notwithstanding anything contained in the Code of Criminal Procedure, 1898 (Act V of 1898) an offence under this Act shall be triable summarily by any Magistrate, exercising the powers of a Magistrate of the first class.
- 14. Officers, etc. deemed to be public service: Every Registration Officer and every other person employed in connection with Registration and issue of identity cards shall be deemed to be a Public servant within the meaning of section 21 of the Penal Code (Act XLV of 1860)
- **15. Power to makes rules:**The Government may, by notification in the official Gazette make rules for carrying out the purposes of this Act.
- **16. Delegation of powers:**The Government may, by notification in the official Gazette, direct that all or any of the powers conferred on it by this Act or the rules shall, subject to such conditions, if any, as may be specified in the notification, be exercisable also by any officer of the Government.
- 17. **Identity:**No suit, prosecution or other legal proceeding shall lie against the Government, any Registration Officer or any other person exercising any powers or performing any function under this Act, for any thing which is in good faith done or purporting or intended to be done under this Act or any rules.

- for which it is required by or under this Act to be possessed or produced."
- 18. Removel of difficulties; If any difficulty aries in giving effect to any provision of this Act, the Government may make such order, not in consistent with the provision of this Act, as may app ear to it to be necessary for the purposes of removing the difficulty.

- **19. Repeal:**National Registration Ordinance 1975 (Ordinance No, XII of 1975) is hereby repealed.
